These jump outs are governed by the Rules of Racing. Trainers are reminded to have educated their horses to barriers prior to bringing them to the jump outs. FEES: \$35 per trial. **FEES MUST BE PAID PRIOR TO JUMP OUT or arrangements made for charging through RVL. Scratching fees apply – half nomination fee i.e. \$17.50 Scratchings must be advised to Elaine prior to trials.**

DISTANCES: 800 and 1350m. **BLINKERS/BARRIER CERTIFICATES** – Trainers must notify Elaine at the time of entry if they will be requiring a jump out for BLINKERS or a BARRIER CERTIFICATE.

REGISTRATION PAPERS must be provided for Stewards. Stewards insist that colours must be worn. Horses from the same stable may wear the same colours in each jump out.

RIDERS must be approved by the Stewards to ride in jump outs
